

B) Committee Strategic Plan: Goals and Accomplishments

1) Continue to grow counsel membership as well as improve/streamline retention of current NYSCHP members

Committee goals:

- a) Create a report that shows us newly expired and soon-to-be expired members
 - a. **Update:** Report created in summer of 2018 and emailed out to committee members every month
 - b. Local membership chairs will reach out to these members personally to serve as a "conduit" for renewal
- b) Gather data on membership retention
 - a. Good data exists on the growth of the organization, but little exists on retention numbers
 - b. **Update**: A spreadsheet was created early 2019 to document expiring members and their demographics, as well as efforts to help retain them
 - c. Data collection ongoing
- c) Better align NYSCHP with ASHP
 - a. Efforts have been made in the past to create a "joint" membership for both the state level organization and the national organization
 - b. **Update**: Ongoing. Discussions have been and continue to be had with other state level organizations as well as ASHP as to the benefits, downfalls and implications of potentially having a joint membership
- d) Offer potential automatic membership renewal
 - a. **Update**: Ongoing. Discussions continue to be had with the council and managing partners to see if this is viable and what might be involved

A) Committee Strategic Plan: Goals and Accomplishments

- a) Aid Education and Workforce Development Committee in improving student clinical competition at the House of Delegates, as well as promoting student programming
 - 1) 2018 was the first year for the student clinical competition and it was a success
 - 2) Worked with committee to recommend several changes for improvement, including a new "buzzer" system, establishing criteria for participants and difficulty of questions
 - 3) Recommended that our committee help "vet" the questions that are written to make sure that they are well understood by students
 - 4) Flyers were disseminated to schools promoting the competition as well as the new student programming for the 2019 Annual Assembly
- b) Address resolutions that were sent back to our committee from 2018 House of Delegates
 - 1) There were 2 resolutions that were sent back to our committee from the 2018 HOD
 - 2) One stated that NYSCHP supports and encourages all New York State schools of pharmacy to align both their IPPE and APPE schedules
 - a. After much discussion and consultation with various schools' Deans and offices of experiential education, the committee determined that there are too many variables for NYSCHP to support all schools going on the same schedule and recommends not to go forward with that resolution.

- b. Consortia exist between the schools of pharmacy in New York State; the committee recommends to leave those decisions up to them to determine what is best for scheduling
- c. The committee recommends staying close and gathering perspectives of preceptors and health care sites to determine what their needs and desires are as it comes to precepting students
- 3) The 2nd resolution dealt with encouraging that all New York State Schools of Pharmacy offer a Bachelor in Professional Studies (B.P.S.) in Pharmaceutical Studies to all of their students within their Pharm.D. program
 - a. The committee agreed with the intent of this resolution but wanted it reworded as some programs are 0-6, some are accelerated, etc.
 - b. The new proposed resolution reads: "The New York State Council of Health-system Pharmacists supports the recommendation to request that all New York State schools of pharmacy offer the opportunity to obtain a Bachelors in Professional Studies Degree to the students enrolled in their professional program with additional areas of study and opportunities in the career of pharmacy."
 - c. The committee was pleased to find out that most schools of pharmacy either already have this in place or are actively working on implementing it.
