In order for the Technician to have a voting privileges, the Council would need to redefine all membership categories. Additionally, with the streamlining of the Board of Directors, it would not be recommended to add another Board member. The Board elected to have the technician attend the BOD meeting similar to the student representative. The Board will need to determine qualifications and identify the Technician representative. No changes are needed to the Constitution and By Laws by following this approach.
