Continuing Competency Committee Update

The Continuing Competency Committee, under the leadership of Joe Pinto, Director of Workforce and Education, and Heide Christensen, Continuing Competency Committee Chair, continue to work tirelessly in planning for educational programming throughout the year. We are fortunate and privileged to have a Committee comprised of dedicated members with expertise across a wide-range of clinical practice settings that have enabled us to offer high quality educational programs.

The ever popular Jan Keltz Memorial Winter Program held at Lake Placid, NY kicked off 2015 and as expected was highlighted by great educational programs, professional networking, and of course unlimited fun on the slopes and in the Olympic Village. Right around the corner is the Downstate Pharmacotherapy Program, which will be held on March 8th. The Downstate program, will offer 4 hours of CE on the following topics: An Update in Pharmacotherapy of Epilepsy, An Update in Pharmacotherapy COPD, Management of Otitis Media, Sinusitis, and CAP in Pediatrics, and New Medication Update.

The 2nd Annual Technology Summit, which is a collaborative program between NYSCHP, PSSNY, NYS ACCP, Albany College of Pharmacy, and ASCP, will be held on March 20th at Albany College of Pharmacy and Health Sciences. Entitled "Clinical Informatics and Emerging Pharmacy Practice Opportunities", this program will offer 5 hours of relevant, current, and future trends in Pharmacy Technology continuing education.
