Dr. Cheng received a Bachelor of Science in Pharmacy from Long Island University. In pursuit of a career in the health care system, she went on to complete a year of pharmacy residency training at Montefiore Medical Center and then to graduate school where she received her doctorate degree in Pharmacy from the State University of New York at Buffalo. She is also a Board Certified Pharmacotherapy Specialist. As a Clinical Pharmacy Manager, some of Dr. Cheng's responsibilities include rounding in the Coronary Care Unit, monitoring patient medication profiles to ensure optimal therapy, evaluating medications for the hospital's formulary, precepting pharmacy residents and students, and contributing to research and publications. Dr. Cheng coinitiated and currently works as a clinical pharmacist at a Collaborative Drug Therapy Management program for heart failure patients.

During her many years at Montefiore Medical Center, Dr. Cheng developed a strong interest in Cardiology and focused many of her publications in this area. Dr. Cheng is a co-editor of the book *Current*

Robert DiGregorio is Senior Director of Pharmacotherapy Services at The Brooklyn Hospital Center (TBHC) and a full Professor at Long Island University's Arnold & Marie Schwartz College of Pharmacy. He is also the

Residency Program Director for both the PGY1 and Ambulatory Care PGY2 programs at TBHC. Dr. DiGregorio is a board certified ambulatory care pharmacotherapy specialist (BCACP) and practices in a series of Collaborative Drug Therapy Management clinics at The Brooklyn Hospital Center. He has over 26 years of experience as a pharmacist, having worked in a variety of settings, including: clinical research, pediatrics, emergency medicine, disaster management, pharmacy administration, ambulatory care, and academia. He has published in the pharmacy, nursing, and medical literature; including serving as an editor of two editions of a textbook. He has been an invited speaker to hundreds of presentations throughout the nation and has presented numerous poster and platform presentations at local, regional, and national conferences.

Dr. DiGregorio is an active member of the New York State Council of Health-system Pharmacists (NYSCHP) at the state and local level. He participates in both the Long Island and Royal Counties Chapters of NYSCHP and will be starting his third term on the Board of Directors of NYSCHP as Director of Pharmacy Practice. He has been a leader in the development of Collaborative Drug Therapy Management in New York State and has represented his colleagues on the ASHP PPMI Ambulatory Care Consensus Panel. Locally, Dr. DiGregorio cofounded the New York City Regional Pharmacy Residency Conference, held annually at Long Island University since 2006. Dr. DiGregorio founded the PGY1 pharmacy residency and implemented PGY2 programs in Ambulatory Care, Infectious Diseases and Emergency Medicine.

# **LOGO RE-DESIGN COMPETITION RULES**

NYSCHP is looking to redesign its logo. With the expanding role of pharmacists in the healthcare system, the profession of pharmacy has evolved over the years. A new logo can mean better representation of the pharmacists' new roles, and the organization's mission and vision.

To create a logo for NYSCHP that captures the attention of the public while depicting the core principles of NYSCHP and the profession it represents.

Guidelines for logo design
Must contain NYSCHP and elements that describes the council's vision, mission, and goals
Symbols used must be simple and bold, and representative of NYSCHP and the profession of pharmacy
Logo must be easily recognizable and memorable
Logo must be versatile and scalable, able to work across a variety of medium or applications (social media, videos, slide presentations, letterheads, business cards, pins, t-shirts, envelopes, etc.)
Logo must be originally designed
Avoid clichés
Avoid plagiarism
Refrain from using too many colors
Provide a brief narrative behind the design concept
Optional: A tagline (example "pharmacists advancing healthcare")
Use Microsoft publisher or Adobe pdf when submitting the logo

**Contest rules:** Only for active NYSCHP members. BOD members are not qualified to participate. Please follow the logo design guidelines. Failure to do so will result in an automatic disqualification. Please submit your logo design to **catherine.millares-sipin@touro.edu** or **sflynn@nyschp.org**. You shall receive an email confirmation after submitting your design. The final winner shall be recognized at 2017 NYSCHP Annual Assembly. The winner will also receive a complementary registration for the 2017 Annual Assembly. Deadline for submission is **November 30<sup>th</sup>**, **2016**.
